Carbon Border Adjustment Mechanism (CBAM)


As part of the further implementation of CBAM, FORWARD Belgium provides a series of practical templates and informative documents. They assist you in the contractual and operational definition of CBAM obligations within your role as a customs representative.

Available via our website:

- **Templates for indirect representation** (EU customer and non-EU customer), distinguishing between situations in which you do or do not include CBAM obligations.
- **Template for direct representation**, with a clear delineation of responsibilities.
- **General information document about CBAM**, which can be used to explain the process to customers.
- **English and French versions** of all documents (free translations).

Remant Transport Architects wins FORWARD Goals Award 2025

Remant Transport Architects receives the FORWARD Goals Award 2025 for the strong commitment of its **sustainability project group**. This group of ten committed employees from all levels of the organisation forms the beating heart of Remant's sustainability approach. Using a bottom-up approach, they translate strategic objectives into concrete actions on the work floor and create broad support within the company.

The project group makes sustainability tangible in daily practice, with initiatives focusing on well-being, health, the circular economy and environmentally conscious choices. Inspiring examples include the **Remant Health Club**, which focuses on the physical and mental resilience of employees, and **REKUPP**, through which Remant contributes to the circular economy via logistics solutions.

With their enthusiasm, leadership and connecting power, Remant shows how motivated employees can bring about real change. For this reason, the jury has awarded Remant Transport Architects the **FORWARD Goals Award 2025**.



Update on European deforestation regulation

The European Parliament has agreed to amendments to the **European Deforestation Regulation (EUDR)** and to postponing its effective date. This allows more time to improve the European Union's IT system and eases the administrative burden on some companies.

Large companies and intermediaries will not have to comply with the obligations until 30 December 2026. For a new category of micro and small enterprises, the date has been moved to 30 June 2027.


Supply Chain Experience Day – register now!
