Following receipt of the required documents and annexes, your application will be submitted to the managing body for assessment, after which - after approval - you will be invited to pay the contribution.

The contribution for the year 2024-2025 (01.03.2024-28.02.2025) is composed of a onetime entry fee of EURO 620 and a fixed amount per company per year depending on the number of white-collar workers:

- 1 5 white-collar workers: EURO 1.700
- 6 10 white-collar workers: EURO 2.100
- 11 15 white-collar workers: EURO 2.500
- 16 20 white-collar workers: EURO 2.900
- 21 30 white-collar workers: EURO 3.300
- 31 40 white-collar workers: EURO 4.100
- 41 50 white-collar workers: EURO 4.600
- +50 white-collar workers: EURO 5.400

We base this on the number of white-collar employees, as stated in the most recent publication of the social balance sheet.

(These contributions are always revised at the general meeting in February.)
